

**THE HONORABLE DAVID NOCE** is a magistrate judge, U.S. District Court, Eastern District of Missouri. He taught business law in college before serving as a legal officer on active duty in the United States Army from 1970 to 1972. From 1972 to 1975, he was the law clerk for two federal district judges in St. Louis. From 1975 to 1976, he served as an assistant United States Attorney, prosecuting federal criminal cases.
