### **PROGRAM**

Under the tutelage of experienced defense trial attorneys, students will perform as defense lawyers in a complete civil trial. The program is a combination of demonstration and lecture by veteran faculty and individual "learning by doing" by student registrants. The program begins Wednesday afternoon, March 31<sup>st</sup>, and concludes Friday afternoon, April 2<sup>nd</sup>.

### **STUDENT BODY**

The Trial Academy is designed for younger lawyers with litigation experience and who have been in practice from one to five years. Student participation requires pre-program preparation by students and faculty. The program is designed for those who are serious about improving their trial skills. (Translation: Don't sign up unless you are willing to work, both before and during the program!)

### **FACULTY**

Demonstrations, lectures and critiques provided by experienced trial lawyers and judges.

### **COURSE MATERIALS**

Materials will be distributed, along with agenda, after receipt of your enrollment.

### **MCLE CREDITS**

Student participation will be approved for a minimum of 16 hours credit and most likely up to 19. It will include 1 hour of ethics credit.

### **COST**

Registration fee is \$865. Includes Wednesday and Thursday nights' single room lodging at the Courtyard by Marriott Columbia, lunch on April 1<sup>st</sup>, cocktail reception, and course materials. Students are responsible for all additional charges, including incidental expenses and additional room charges.

### **ENROLLMENT**

Limited to thirty-five (35) students. We expect enrollment demand to exceed available slots. Accordingly, slots will be filled strictly in accordance with order of receipt of registration checks by MODL pursuant to registration form below.

### **CANCELLATIONS**

Full refund will be granted if cancellation is received prior to March 13<sup>th</sup>. Refunds amounting to 50% of the fee will be granted after March 13<sup>th</sup> unless the slot is filled, in which case a full refund will be granted.
